Cancellation Outside of Lead Time Policy

Cancellation Terms: Samtec will allow cancellations and reschedules when requested outside of the lead-time of the quantity ordered. Normally 3-5 days for volumes up to 1,000, 10 days for 5,000, 20 days for 10,000 and 30 days for higher volumes. Application Specific Products (ASP/SEP/MEP/SCF) are special orders and must be approved by Samtec prior to cancellation. Cancellation charges may apply for any product cancelled within the lead-time window. (Lead-times may change based on material availability.)

Return Guidelines: Samtec is a build to order manufacturer with lead-times of 3-5 days, therefore returns are limited to selected full strips or products approved by Samtec for return.
