Individual License An individual license allows the products to be used by a single named user designated by the Licensee. The products may be installed on one or more stand-alone computers (for example, at work and at home), provided that the products are only accessible to, and operated by, that single named user. Licensee must specify platform (Windows, Linux, UNIX, or Macintosh OS X.)

Commercial Group License Group administered licenses are intended for sites where a single systems administrator installs and maintains the products on a group of computers. A Group license allows products to be installed and used by a specified number of designated named users, with the same restrictions as noted for Individual licenses. A Group license may also be installed to operate for the set of designated named users over a network. It is the responsibility of the Licensee to track and control the number of users of each licensed product. The minimum number of Named User licenses that must be enrolled in Software Maintenance is 5.

Concurrent License Concurrent licensing allows products to be licensed per concurrent user on computers that are connected to a server running a single license manager. The product is not restricted to named designated users; instead, it allows a specified number of concurrent users to run the products on any computer on a local area network. Pricing is determined by the number of concurrent users. This license option is available for Windows, Linux, UNIX and Macintosh OS X systems as long as they operate under a single license manager on a local area network. Users located outside the country in which the license manager server is installed may not access the programs unless the Licensee has contracted for global use.

LICENSE TERM

The Individual, Group, and Concurrent license options are licensed on a PERPETUAL basis, providing the right to use the software indefinitely. The initial purchase price of a Perpetual license includes software maintenance service for the first 12 months. After the initial 12 month period, an annual software maintenance fee is required to renew your software maintenance service. Software maintenance service provides product updates and technical support.

DOCUMENTATION

You may purchase additional documentation for any product you have licensed. The price is \$55 for MATLAB user documentation and \$35 each for all other documentation.

SOFTWARE MAINTENANCE SERVICE

Product Updates. You are entitled to product updates if you are current under the annual software maintenance service. The annual software maintenance service renewal fee is calculated based on the products installed in your configuration and the licensing option. If your software maintenance service lapses, you may reinstate it within four years of the expiration date by paying for the lapsed maintenance term plus a reinstatement charge. Shipping and handling fees for product updates are included in the software maintenance service renewal fee.
