

STATEMENT TO CONTRIBUTORS

The IEEE JOURNAL OF OCEANIC ENGINEERING is intended as a medium for the publication of papers that emphasize the application of fundamental electrical and electronics knowledge and technology to oceanic research and development. Design, testing and application of water-oriented systems, subsystems, and components applications of electrical and electronic engineering pertaining to all bodies of water are appropriate. Review papers, designed to bring the engineer into contact with developing trends, are also suitable, and Technical Communications, or papers presenting data and other results in convenient form for rapid use in design practice, are encouraged. Throughout the year, collections of papers focusing on specific topics are published as Special Issues. Regular issue contributed papers on other topics are accepted for publication in these issues as well, and are placed in a "Regular Issue Papers" section. The Editors reserve the privilege of making the final decision concerning the classification and publication of any paper.

Author Responsibilities: Manuscripts submitted for publication should be original work submitted to a single Journal. It should not have been previously published and should not be under consideration for publication elsewhere. The IEEE assumes that material submitted to its publications is properly available for general dissemination for the readership of those publications. It is the responsibility of the authors, not the IEEE, to determine whether disclosure of their material requires the prior consent of other parties and, if so, to obtain it. If an author uses charts, photographs, or other graphics from previously printed material, he/she is responsible for obtaining written permission from the publisher to use the material in his/her manuscript. Statements and opinions given in work published by the IEEE are the expressions of the authors. Responsibility for the contents of published papers rests upon the authors, not the IEEE.

Submission Process: Authors should send their manuscripts to the Associate Editor whose specialty group (listed on the inside front cover of the JOURNAL) best fits the technical content. All submissions must be accompanied by a covering letter. Contact information should be provided for all authors, including E-mail address, telephone number, and fax number. The corresponding author should be identified. It is also useful to provide the Editor with any information that will support the submission (e.g. original or confirmatory data, relevance, topicality). The original plus three copies should be submitted. Authors should retain a copy of their manuscript since we cannot accept responsibility for damage or loss of papers. It is recognized that prompt publication is highly desirable. To facilitate the review process an author may wish to provide the Associate Editor with an electronic copy of their manuscript abstract for use in forwarding to potential reviewers. **Copyright:** An IEEE copyright form should accompany your submission. You can get a copy from the first issue in each volume of the JOURNAL or download a .pdf, .html, or .doc version at <http://www.ieee.org/copyright>.

Manuscript Preparation: Information for Authors is available at <http://www.ieee.org/organizations/pubs/transactions/information.htm>. Manuscripts submitted for review should be typewritten, and double-spaced. Good quality printouts with a font size of 12 or 10 pt are required. Full postal addresses must be given for all co-authors. Since the Journal publishes only in English, contributors for whom English is not a native language should consult a competent colleague or service for the purpose of editing the original manuscript. The Editors reserve the right to adjust style to certain standards of uniformity. An electronic copy of the paper should accompany the final accepted version. **Paper Length:** The JOURNAL does not set specific limits on paper length. Manuscripts must be carefully prepared and written in a clear, concise style. Paper length should be appropriate to the topic.

Abstracts: The essential contents of each paper should be recapitulated briefly in an abstract of not more than 200 words at the head of the paper. (Each letter and each erratum should include an abstract of not more than 50 words.) **Keywords:** Please provide three to five subject keywords suitable for indexing.

Text: The following order should be used when typing manuscripts: Title, Authors, Affiliations, Abstract, Keywords, Introduction, Main text, Acknowledgments, References, Biographical Notes, Figures and then Tables. Do not import the Figures or Tables into your text. Abbreviations and acronyms must be fully spelled out on first appearance in the abstract and also in the text of the manuscript. **Units:** The International System of Units (SI units) is advocated for use in IEEE publications. Refer to the units list provided as Appendix I in the *Information for Authors Guide*.

References: A numbered list of references must be provided at the end of the paper as a separate page or pages of the manuscript. The list should be arranged in the order of citation in text, not in alphabetical order. Each reference number should be enclosed by square brackets. References must be complete and in IEEE style as indicated in the *Information for Authors guide*.

Biographical Information: Biographical notes and a recent photograph of the author(s) will be included in this JOURNAL after each paper and each communication. The form typically used in IEEE journals consists of three paragraphs of information: 1) name, where and when born, degrees earned, field(s) of study, school, city, state; 2) chief employment dates, organizations, positions held, type of work, responsibilities, present position; and 3) professional society membership, offices, awards. The final printed size of an author photograph is fixed at exactly 1 inch wide by 1 1/4 inches long (6 picas x 7 1/2 picas).

Figures and Tables: All graphics should be submitted as separate items from the body of your paper on separate sheets of paper or on disk. Line art, graphs, charts, tables, drawings, photos, and gray scale diagrams will be scanned electronically for final production or you may submit them as TIFF, PostScript, or Encapsulated PostScript files (see section on Electronic Files). Tables should not duplicate results presented elsewhere in the manuscript (e.g. in graphs). If submitting for scanning, all graphics should be original proofs and not photocopies. Whenever possible photos should be glossy prints with no screening. Laser prints will not reproduce as well as original photos. All line drawings and photos should be supplied as they are to be reproduced (e.g. black and white or color). Please use consistent typefaces on all your figures. Figures will be reduced to make the smallest type-size 8 points. Generally one or two typefaces should suffice. DO NOT put boxes around your figures to enclose them. Captions should be included as a separate list at the end of the paper.

Electronic Files: Authors should submit an electronic copy of their paper with the final accepted version of the manuscript. The electronic copy should match the hardcopy exactly. LaTeX and MS Word style files can be downloaded from: <http://www.ieee.org/organizations/pubs/transactions/stylesheets.htm>. Guidelines may be found at <http://www.ieee.org/organizations/pubs/transactions/information.htm>. Author supplied electronic graphics in PostScript, Encapsulated PostScript (EPS), and Tagged Image File Format (TIFF) are accepted. Figures should contain only the image and not the caption text. Please submit your graphics on disks separate from your manuscript. Figures should be named fig1.tif, fig2.eps, fig3.ps, and so forth. Do not give them descriptive names.

Proofs: IEEE may send out galley proofs to authors via email as pdf files. Proofs will be sent via this method whenever possible, rather than by fax/mail. Proofs will be sent to the author (first named author if no corresponding author is identified of multi-authored papers). If authors are expecting to be away from their office when the proofs arrive, arrangements should be made with colleagues for the proofs to be checked in the author's absence.

Page Charges: After a manuscript has been accepted for publication, the author's company or institution will be requested to pay a charge of \$110 per printed page to cover part of the cost of publication. Minimum charge will be for one page. Page charges for this JOURNAL are not obligatory, nor is their payment a prerequisite for publication. The author will receive 100 free reprints without covers if the charge is honored. Detailed instructions will accompany the page proof.

Peer Review: The JOURNAL employs the peer-review system in the processing of manuscripts submitted for publication. Each manuscript is sent usually to three reviewers who are experts in the field in question. The review may take up to 12 weeks. Decision as to the publication of the paper is based on the opinions expressed by the reviewers and the judgment of the Associate Editor to whom the manuscript was submitted. Reviews are passed on to the contributor, who is entitled to make use of them or rebut them. Serious differences of opinion between the contributor and the reviewer with respect to the acceptability of a paper may be brought to the attention of the Editor, who will endeavor to provide a final adjudication. Anonymity of the reviewers is maintained throughout the review process. By reciprocity, authors are entitled to request anonymity with respect to all reviewers except the cognizant Associate Editor and the Editor. Such a request should be explicitly stated in the cover letter accompanying the submission of the manuscript. The author is responsible for all deletions of his or her name in the manuscript. Anonymity of the author(s) is automatically terminated upon acceptance of the manuscript for publication. General questions with regard to the peer-review process should be addressed to the Editor.

Author checklists

For review:

- Four copies of the manuscript, figures, tables, and index terms (Original plus 3 copies)
- Complete author contact information
- Signed IEEE copyright form

For final submission:

- Three printed copies of the manuscript, figures, tables, and index terms
- Mailing addresses, email, telephone numbers and fax numbers of all authors
- Signed IEEE copyright form (if not already provided or title and/or authorship has changed)
- Photo and biographical information for each author
- Electronic copy of manuscript and figures (or clean, original figures suitable for scanning)
