Estimated Casting Lead Time: 12 weeks from receipt of order, End Use Statement, usable patterns, current drawings, procedure approvals and acceptance of specification requirements by both buyer and Wah Chang.

Note: All dimensional control of castings will be as stated in OMC 105, Para. 4.

Shipping Note: Ownership of FOB Collect orders transfers to the buyer upon pick up by the shipping carrier. Shipments will not be insured unless requested in the Purchase Order. Without insurance Buyer will be responsible for filing the claim with the shipping carrier and for full payment of the Wah Chang invoice if the carrier loses the shipment.

Note: Order entry cannot be started until the End Use Statement is received.

Final as cast weight discrepancies greater than 5% of customer supplied weights may require cost adjustment.

Order Cancellation Note: If an order is cancelled after castings are poured the cancellation charge will be the full value of the quoted casting cost.
