Xbee Relay Software License Agreement

This Software License Agreement (“License”) is entered into between Liquid Robotics, Inc., a California corporation, (“LRI”), and the recipient of the Xbee Relay Software (“You” or “Your”).

By installing and running the provided software or selecting an “accept” button related to this agreement, You enter into this License and You agree as follows:

1. License Grant. Upon the payment of the License Fees and subject to the terms and conditions of this License, LRI grants to You a limited, non-exclusive, non-transferable worldwide license to use the software provided to You by LRI (the “LRI Software”) and any accompanying documentation (“LRI Documentation”).

2. Limited Use. You may install the LRI Software and use the LRI Software to communicate with Your Wave Glider Vehicle(s). The LRI Software may be used by an unlimited number of users solely for the purpose of communicating with Your Wave Glider Vehicle(s). You may use the LRI Documentation only in conjunction with and to facilitate Your use of the LRI Software as permitted by this License.

3. Copying LRI Software: If the LRI Software is provided to you by LRI, You may make copies of the LRI Software in machine readable form provided that You reproduce all proprietary notices on the copy.

4. Restrictions. You may not:

- (i) use the LRI Software or LRI Documentation except as provided in Section 2 herein; without the express written consent of LRI;
- (ii) modify, translate, reverse engineer, decompile, disassemble, create derivative works, or copy (except for the authorized back-up copy) the LRI Software or the LRI Documentation or any portion thereof;
- (iii) sublicense the LRI Software or LRI Documentation except with LRI’s prior written consent;
- (iv) sell, distribute, assign, rent, operate a service bureau, transfer or grant any rights in the LRI Software or LRI Documentation in any form to any person; or
- (v) remove any proprietary notices, labels, legends or marks on the LRI Software and LRI Documentation;
- (vi) disable, remove or circumvent any access control, security feature, procedure or process established with respect to the LRI Software. Failure to comply with the above restrictions will result in automatic termination of this License.

5. Reservation of Rights. LRI retains all rights not expressly granted to You, and retains all right, title and interest in and to the LRI Software and LRI Documentation, including without limitation all copyrights, patents, trade secrets, trademarks and other intellectual property right therein. The LRI Software is licensed to You for Your use only in accordance with this License, and is not sold. Nothing in this License shall be construed to confer any license or right with respect to any patent, trademark or tradename.

6. Limited Consent to Sublicense. LRI hereby provides You with written consent to sublicense Your right to use the LRI Software, and LRI Documentation only to _____. (None if blank.)

7. Obligations. You are wholly responsible for the use of the LRI Software and LRI Documentation LRI has delivered to You or to which you have been provided access by LRI and for any data or database used with such software, and for the security assurance associated with the use of such software. If LRI provides to You any fix, upgrade, update, enhancement or new release of the LRI Software, You agree to install or otherwise use the LRI Software only with such fixes, upgrades, updates, enhancements or new release. LRI only supports the current version of the LRI Software.

8. Jurisdiction and Choice of Law. To the extent that You are a United States Governmental entity or agency, this License shall be governed by applicable federal law. To the extent You or your authorized sublicensee is a commercial entity, this License is governed by the laws of the State of California without regard to its conflict of laws provisions, and You hereby expressly consent to the personal jurisdiction of any court sitting in San Francisco, California and waive jurisdiction of any other state and federal court, for any dispute arising under or relating to this License. BOTH PARTIES ALSO WAIVE ALL RIGHTS TO A JURY TRIAL IN ANY DISPUTE CONCERNING THIS LICENSE.

9. Disclaimer of Warranties. LRI DISCLAIMS ALL EXPRESS, IMPLIED OR STATUTORY WARRANTIES WITH RESPECT TO THE LRI SOFTWARE, INCLUDING ANY WARRANTIES OF QUALITY, COMPLETENESS, MERCHANTABILITY, FITNESS FOR PARTICULAR PURPOSE, AND/OR NON-INFRINGEMENT. THE LRI SOFTWARE IS PROVIDED “AS IS” AND WITH ALL FAULTS, AND YOUR USE OF THE LRI SOFTWARE IS STRICTLY AT YOUR OWN RISK. IN NO EVENT WILL LRI BE LIABLE FOR ANY SPECIAL, INCIDENTAL, DIRECT, INDIRECT, EXEMPLARY OR CONSEQUENTIAL DAMAGES OR LOST PROFITS WHATSOEVER ARISING OR RESULTING FROM YOUR USE OR MISUSE OF THE LRI SOFTWARE, WHETHER OR NOT LRI HAS BEEN ADVISED OF THE POSSIBILITY OF THE SAME.

10. Indemnification. You acknowledge that LRI has no knowledge of and no control over the manner in which You actually use the LRI Software or any data used in conjunction with the LRI Software. You agree to indemnify, hold harmless, and defend LRI from and against all claims, damages, demands, or lawsuits, including attorney’s fees, that arise or result from Your use or misuse of the LRI Software, or the violation of any of the terms of this License by You or Your authorized sublicensee.

11. Commercial Software. If You are the a Federal Governmental entity or agency, or a prime contractor or subcontractor (at any tier) under any contract, grant, cooperative agreement or other activity with the Federal Government, by accepting delivery of the LRI Software, You agree that this software qualifies as “commercial” computer software within the meaning of the applicable Federal Acquisition Regulations. License shall supersede any conflicting contractual terms or conditions, except to the extent that FAR clause 52.212-4 is a mandatory clause applicable to this License or to a contract executed in conjunction with this License, in which case if a subsection of FAR clause 52.212-4 conflicts with and cannot be harmonized with a specific term of this License, such subsection shall control over such specific term. If this License fails to meet the government's needs or is inconsistent in any respect with Federal law, You agree to return the LRI Software, unused, to LRI.

12. Termination. Your rights under this License will terminate automatically without notice from LRI if You fail to comply with any term(s) of this License. Upon termination of this License, You shall cease all use of the LRI Software and destroy all copies, full or partial, of the LRI Software.

13. Export Regulation. You shall not cause or permit any person to cause the delivery or transmittal of the LRI Software, through transshipment, electronic transmissions, or otherwise, to any person or into areas subject to export or trade restrictions by the U.S. Government, without full compliance with all applicable export control and trade laws, and without advance written authorization by LRI.

13. Miscellaneous. This License is the entire agreement held between us and supersedes any other communications or advertising with respect to the LRI Software. This License shall not be modified or amended except by written amendment signed by both Parties. If any provision of this License is unenforceable for any reason, the remainder hereof will continue in full force and the unenforceable provision will be deemed modified as necessary to make it enforceable while still keeping as close to the original provision's purpose as possible. The waiver by LRI of a default or breach of any provision of this License shall not operate or be construed as a waiver of any subsequent default or breach. LRI is entitled, in addition to any other remedy or relief available at law or in equity, to specific performance and/or injunctive relief in the event of Your default or breach of this License.
