Payment

NET 30 days with Accounting approval from date of invoice, unless otherwise agreed to and noted on Invoice/Order Acknowledgement. All Invoices paid after the due date will be assessed a finance charge of 2% per month (which is an annual rate of 24%) or the maximum allowable by law, whichever is lower and will be applied to the balance at the next billing. On all credit card payments, a fee of 4% will be charged

Delivery

As defined by Incoterms 2020. Title, risk, and insurance liability are deemed to have been transferred to the Buyer when the goods are completed, tested, packed, and made available to the Buyer at Seven Valley Specialty Cables's facility. The Seller will supply weights and dimensions to the Buyer when ready to pick up.

Storage

Due to the growth in activity, size, and complexity of our products, our storage areas can often be compromised. Therefore if products are not collected quickly after completion, off-site storage at a secure location must be considered, and the associated costs and insurance covered by the Buyer.

Material and sub-component volatility

While at the time of the bid or quotation, Seven Valley Specialty Cables's offer is firm, there are occasions out of Seven Valley Specialty Cables's control when there will be a level of uncertainty due to material price fluctuation. This is mainly due to two reasons; the special nature of our designs resulting in non-standard material selection and market volatility due to geopolitical influences or exchange rates. Price movement on material supply due to these or any other factors will result in Seven Valley Specialty Cables reserving the right to adjust our pricing accordingly.

Warranty

Seven Valley Specialty Cables will repair or replace at their option any goods which are, or which become, defective within the agreed warranty period due to faulty workmanship, materials or faulty design if Seven Valley Specialty Cables is responsible for design, provided that the Buyer notifies Seven Valley Specialty Cables in writing of any defect. All expenses incurred in connection with the defective goods' return, including all transportation costs, shall be paid by the Buyer. Warranty period is typically 12 months from completion unless otherwise agreed.

Seven Valley Specialty Cables's liability in respect of defects in the goods shall be limited to those stated in this clause and subject to Clause 2(1) of the Unfair Contract Terms Act 1997, the Seller shall not be liable whether in contract or in tort, including but not limited to negligence, or by reason of breach of statutory duty or otherwise, for any damage or loss whatsoever suffered by the Buyer arising out of or attributable to such defects.
