

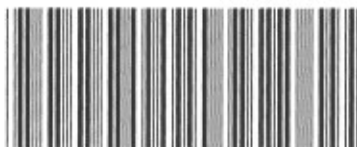

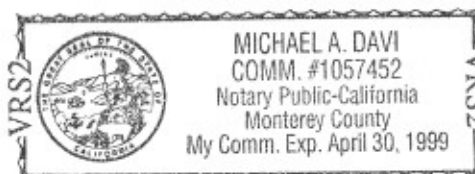

EXHIBIT "A"

The land referred to is situated in the State of California, County of Monterey, in the unincorporated area, and is described as follows:

PARCEL I:

A portion of Monterey City Lands Tract No. 3 and also portion of Parcel 4, as described in that certain Deed dated December 23, 1926, from Wm. Sandholdt to Minnie Sandholdt and recorded in Volume 96, Page 447, Monterey County Official Records, more particularly described as follows:

Beginning at the Southeasterly corner of said Parcel 4 and running thence, Westerly along the Southerly boundary of said Parcel 105.4 feet; thence Northerly at right angles 30 feet; thence, Easterly at right angles to the Easterly side of said Parcel, 94.6 feet; thence Southerly and along the Easterly side of said Parcel 4, 31.87 feet to the place of beginning. The Lot hereby conveyed is known as Lot 28 in said Parcel.

PARCEL II:

Being a part of Monterey City Lands, Tract No. 3, recorded in Volume F of Patents, Page 178, Records of Monterey County, California, and being a tract of land on the South side of the Entrance Channel to Moss Landing Harbor bounded as follows:

Bounded on the South by the North boundary of lands conveyed by Wilbur C. Sandholdt, et al, to David C. Kriby, Frank Arnone and Pete Lomanto, by Deed recorded January 14, 1955 in Volume 1581, Page 310, Official Records of said County and by the lands described in the Deed to Dolores M. Fitzgerald, recorded April 1, 1976 in Reel 1044 of Official Records of Monterey County at Page 88.

Bounded on the West by the Bay of Monterey:

Bounded on the North by the South boundary of lands described as "Exhibit "A", Tract No. 1 Entrance Channel", in an Agreement with Moss Landing Harbor District, dated October 23, 1945, recorded December 17, 1945 in Volume 874, Page 46, Official Records of said County and

Bounded on the East by the West line of Sandholdt Road, a strip of land conveyed to the County of Monterey, by Deed dated July 26, 1951 from Lucile Sandholdt, et al, recorded August 1, 1951 in Volume 1319, Page 388, Official Records of said County.
